

EOI for Supply and Installation of canopy with Branding for EV Charging Station across India

Adani TotalEnergies E-Mobility Limited (ATEL) is fully owned subsidiary company of Adani Total Gas Limited (ATGL) and are developing EV Charging infra across India. ATEL is seeking Expression of Interest (EOI) from qualified and experienced contractors for the supply & Installation of Canopy with Branding for Electric Vehicle Charging Stations (EVCS) across India.

Technical Qualification Criteria:

- 1. Contractors having prior experience in canopy and branding works for EV Charging Stations shall be considered for the same.
- 2. Contractors having prior experience in canopy and branding works in other industries may be considered after detailed evaluation of the capabilities.
- 3. PAN India Contractors and the contractors working in multiple state shall be preferred to have better standardization and project control.
- 4. Excellent Project planning, material procurement, HSE and Execution capabilities.
- 5. Bidder must not have been blacklisted / put on hold / de-barred from tendering from any Govt. body, Banks, PSUs, Promoters or any Private reputed Firm in the last 3 years.
- 6. Bidder must not have any open criminal case / investigations against him (Director of the company) or against the company itself.

> Financial Criteria

- 1. Annual Turnover INR 75 lakh as per the last Audited Annual Financial Statements. for qualification purpose
- 2. Net Worth Positive Net worth as per the last audited Annual Financial Statements and not defaulted on NCLT during the last 3 years.
- 3. Bidder should disclose all Bank charges and pending / Open loans Interested vendor should submit their detailed profile, work completion certificate, order copies, CA certified financial statement as per requirement elaborated in below link by no later than 7 days from the date of EOI publication.

Project Overview:

The project involves the supply and installation of canopy with branding on Pan India basis. The successful contractor will be responsible for the supply and installation of canopy with branding of the EV Charging Stations.

Note: Installation and Commissioning of the charger, panel and cabling are not part of the scope of canopy vendor.

> Scope of Work:

1. Supply and Installation of Canopy with Branding:

There are 3 types of canopies, small, big and miscellaneous canopy. Photo of the canopy is attached in the EOI for your reference.

There scope is divided in two parts:

Part A (Mandatory Items) - This shall be executed at every site.



 Part B (Optional Items) - This may or may not be executed at site, it depends on the site condition.
