

## RESIDENTIAL CONNECTION TARIFF CARD

### Single Domestic PNG Connection Includes

- One Point (Gas Tap) in One Kitchen.
- 10 (Ten) metres of pipeline up to the metering unit starting from T.F. (In the case of Bungalow/Tenement/Row Houses).
- 7 (Seven) metres of pipeline from Riser 'T' Point to Gas Metre and 3 (Three) metres of pipeline will be considered in common.
- The metering unit includes (One Domestic Metre [metre type G1.6], one regulator, one metre isolation valve and fitting.
- 5 (Five) metres of GI or copper pipe from the metering unit up to the Gas Tap.
- One wire braided flexible hose (Suraksha hose pipe) of approx. 1 metre in size.

### Important Points

- Underground pipeline work will only be done through the excavation process (Open Cut).
- Boring and breaking off PCC/RCC work would be on a chargeable basis.
- No kitchen point shall be given outside the kitchen premises.
- Horizontal Installation of pipelines will be done only if it is found easily accessible and at the sole discretion of ATGL.
- Resurfacing and restoration work of the excavated area is not under the scope of ATGL.
- Servicing/Repairing of gas stove or burner and conversion of stove other than regular stove is not under ATGL's scope.
- Concealed GI/GU pipelines shall not be given under any circumstances.
- In case there is a requirement for any hole in tiles, stones or platform it will not be under ATGL's scope.
- No waiver in the bill will be given in case of any gas leakage found from the gas stove or rubber tube.
- Geyser point shall not be given inside the bathroom.
