## Observations violate every tenet of law, says SC lawyer

THE SUPREME Court observations while rejecting a plea by Zakia Jafri, wife of former Congress MP Ahsan Jafri who was killed during the 2002 Gujarat riots, are "unpardonable, illegal, unconstitutional and violates every tenet of law", said practising advocte Kamini laiswal on Tuesday.

Speaking in Aĥmedabad on Tuesday, Jaiswal emphasised the observations of "coalesced effort of the disgruntled officials of the state of Gujarat along with others" so as to "keep the pot boiling".

"This judgement of the SC and the way the police has acted against Teesta and others, it is

only meant to be a lesson for people in future. It can be taken as a precedent unless these remarks are expunged... It will be a precedent that magistrate, district court and high court judges will follow. It has enlarged the discretionary jurisdiction for taking action against people who are fighting for justice," she added.

Jaiswal reasoned that such observations against parties who were not before the court and subsequent police action against Teesta Setalvad and others amounts to violation of fundamental rights.

Referring to the verdict, Jaiswal pointed out, "The (SC) (could have) just rejected the appeal and said there's no merit in it... They do not talk of the merits of the case. What is completely
