 Scheme A – Pay in Instalments*(For Charged & Un-charged Society / Apartment)

In this scheme, out of total Rs. 5,400/-, Customer initially needs to pay only Rs. 1,400/- at the time of registration with application form, & balance amount to be paid in instalments of Rs. 1,000/- each in next 4 bimonthly billing cycle (i.e. 8 months).

- a) In case of Apartments, balance amount i.e. Rs. 4,000/-
- b) In case of Bungalows, Tenements & Row Houses, balance amount i.e. Rs. 4,000/- and charges as per the estimate which would be given at the time of connection

 Scheme AA – Pay in Instalments*(For Charged & Un-charged Society / Apartment)

In this scheme, out of total Rs. 5,400/-, Customer initially needs to pay only Rs. 1,400/- at the time of registration with application form, & balance amount to be paid in instalments of Rs. 500/- each in next 8 bimonthly billing cycle (i.e. 16 months).

- a) In case of Apartments, balance amount i.e. Rs. 4,000/-
- b) In case of Bungalows, Tenements & Row Houses, balance amount i.e. Rs. 4,000/- and charges as per the estimate which would be given at the time of connection

 Scheme B – Combo Offer* (For Charged & Un-charged Society / Apartment)

In this scheme, customer will get 1 Extra Point along with 1 Standard Kitchen Connection in just Rs. 6,816/- only, instead of Rs. 8,350/-.

 Scheme E – Super Combo* (For Charged & Un-charged Society / Apartment)
