I, **Chirag Shah, Practicing Company Secretary**, was appointed as Scrutinizer by the National Company Law Tribunal (NCLT) Ahmedabad Bench vide its order dated 10<sup>th</sup> May, 2018 for the purpose of scrutinizing the voting process in a fair and transparent manner at the meeting of the Unsecured Creditors of Adani Gas Limited ("the Company") held on Tuesday, 3<sup>rd</sup> July, 2018 at 4.00 p.m. at J. B. Auditorium, Ahmedabad management Association, Dr. Vikram Sarabhai Marg, ATIRA, Ahmedabad – 380015, in terms of applicable provisions of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014.

1. After the time fixed for closing of poll by the Chairman, two ballot boxes kept for polling were locked in my presence with due identification marks placed by me.

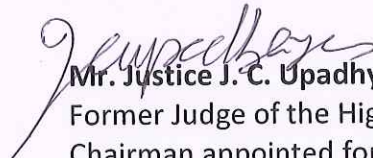
